V.E.S.T. SCHOLARSHIP UPDATE

For the academic year 2020-2021, we awarded two student scholarships, one \$3,000.00 scholarship and one \$1,000.00 scholarship. The first scholarship was awarded to Allan DeBoe who attended the December Zoom meeting and discussed his plans in Software Engineering.

The Second VEST Scholarship was awarded to Donovan Bowler - Industrial/ Mechanical Engineering - May, 2020 GCC Graduate, GPA=3.581, who is attending ASU in 2020/2021. The scholarship of \$1000 will be awarded in January, 2021.

Donovan Bowler is scheduled to attend the January 8, 2021 VEST meeting to provide more information on his backgrounds and to thank the VEST Club for their 2020-2021 scholarship donations.

Donovan was the first in his family to attend college and with a goal to obtain an engineering degree. He is GCC Honor Student and a member of the Phi Theta Kappa (PTK) International Honor Society. In addition, Donovan has participated in several community services projects and organizations. Donovan was raised by a single mother and he soon had to become the man of the house for his younger brother and to assist his mother. This has developed his life goals and his desire to obtain an engineering degree at ASU.

If we are to continue as a club with one of our goals of awarding annual scholarships, we must plan to augment the VEST Scholarship Fund, since only half of the 2021 dues (\$12.50 per person) and the 50/50 Raffle net revenue (average about \$70.00 / meeting) goes directly to scholarship. However, with only the Zoom Meetings we are unable to have the 50/50 Raffle.

The VEST goal each year is to award at least one \$3,000 scholarship and if additional money is available, to award additional scholarships to worthy students. We continue to accept additional scholarship donations. Members enjoyed a suburb program on the Surprise Economic Development Department AZ TechCelerator by Julie Neal, Economic Development Coordinator for the city of Surprise. Julie described how the incubator came to be, how it operates self sufficiently to support development of technical jobs in Surprise, and some of the companies using incubator resources in the past and present. Presentations by two existing companies followed.

Hannah, a biomedical engineer and Co-founder of ReSuture, gave a fascinating presentation on materials and platforms to permit surgeons to train on procedures that are replications of real life surgery. Mr. Glenn Fletcher from Efficient Thermal Energy then discussed a new thermal energy unit to provide a cost effective, renewable energy source that can provide usable water in remote and arid regions and industry.
